In this article, some mistakes have been found. The use of MMAS-8 scales required permission from the copyright owner but was missing, and corresponding data were recalculated using the scoring algorithm of MMAS-8. In agreement with the copyright owner of MMAS-8, the following corrections need to be made to this article.

In the section of "The main outcomes", the scoring of the MMAS-8 scale was incorrectly described. The correct description should read "The Morisky Medication Adherence Scale-8 (MMAS-8) was used to evaluate patients' treatment compliance, with a total score of 8. The MMAS-8 diagnostic adherence assessment instrument has a range of 0 to 8. Low adherence is 0 to <6, moderate adherence is from 6 to <8 and high adherence is 8".

The reference for MMAS-8 (original reference [13]) was incorrect. The correct 3 citations for the actual scoring of the MMAS-8 scale are as follows:




Figure 2. Comparison of MMAS-8 scores between the two groups of patients after intervention. The MMAS-8 scale, content, name, and trademarks are protected by US copyright and trademark laws. Permission for use of the scale and its coding is required. A license agreement is available from MMAR, LLC., Donald E. Morisky, ScD, ScM, MSPH, 294 Lindura Ct., USA; donald.morisky@moriskyscale.com. MMAS: Morisky Medication Adherence Scale. #P<0.05.

The correct description should be "After intervention, the scores of MMAS-8 in the observation group (7.20±0.53) were significantly higher than those in the control group (5.02±0.75) (P<0.05), as shown in **Figure 2**".
